Organizing committee:

-  All clubs and members of the *Fédération de natation du Québec* may organize open water swimming events, provided they obtain a duly awarded sanction.
-  Independent organizers must be members of the *Fédération de natation du Québec* in order to obtain the sanction for an open water swimming event.





Participant:

-  A swimmer can take part in any sanctioned open water events as long as he is a member of the FNQ or of an organisation adherent of the FINA, and thus, without any additional fees.
-  Someone wishing to take part in one or more FNQ's sanctioned open water event must first become an individual member of the FNQ for the duration of the event. Filling the form and paying the adhesion fees will be necessary in order to register for a sanctioned open water event.
-  The *event membership – individual member* form does not replace the *registration and consent* form for an open water event. Both must be filled.


Operating methods:

-  Organizing committee are responsible for ensuring that any generic swimmers, master-swimmers or para swimmers have a valid membership before accepting their registration. In the event where the participant cannot present a valid membership, the organizing committee will have to make them fill the event membership – individual member form, collect the membership fees, and return those fees to the FNQ, along with the completed forms.
-  If the organizing committee fails to collect the said fees, they themselves will have to pay these fees to the FNQ or Swimming Canada.
-  Membership fees are non-refundable and membership is only valid for the event listed.
-  Payment and registration forms must be included with the meet report sent to the *Fédération de natation du Québec* after the event.

Rights and privileges associated with an event membership – individual member in an open water organization:

-  Allows the swimmer to participate in the sanctioned open water.
-  Commits the organizers and the swimmer to respect and follow the *Fédération de natation du Québec* open water security rules, technical guide and Swimming Canada rules.
-  Protects swimmers, coaches and officials, members in good standing of the FNQ, with an accident insurance policy.
-  Ensure compilation and broadcasting of a provincial ranking.

Information uses:

-  The information in this form will be used by the *Fédération de natation du Québec* for the following purposes ; establishment of its annual membership list, management of age categories and age limits during events, compliance with safety regulations and classification of athletes for competition purposes.
